MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023), ¹ [SWT-2023-555]

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA), the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in this state due to litigation.

1. SUMMARY OF CONCLUSIONS.

- 3. REVIEW AREA: The Review area is approximately 15 acres, and located at latitude 35.60531, longitude -97.38817, Oklahoma County, Oklahoma. The site drains from the northeast to the southwest in general.
- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED: Eufaula Lake is the nearest Traditional Navigable Water, an officially designated Navigable Water (Section 10 RHA).
- 5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS: The ditch flows through a culvert into an unnamed tributary, which flows into Arcadia Lake (impoundment of Deep Fork River), the Deep Fork River flows into Eufaula Lake (TNW).

The pond was a constructed impoundment of the uplands at the top of a natural topographic drainage area. The pond has been predominantly dry for approximately ten years based on review of aerial imagery. The NRCS soils data on site are not mapped as hydric soils. The pond lacks an obvious outfall/spillway structure. The agents' delineation report concludes that this feature meets the three criteria as a wetland feature, however, this condition is due to a lack of supporting hydrology to maintain a normal water level within the historic pond. This historic pond is a non-relatively permanent water and is not a water of the United States.

b. Describe aquatic resources and features within the review area identified as "generally not jurisdictional" in the *Rapanos* guidance. Include size of the aquatic resource or feature within the review area and describe how it was determined to be non-jurisdictional under the CWA based on the criteria listed in the guidance.

The ditch is excavated wholly in and draining only uplands and that does not carry a relatively permanent flow of water (NRPW). The ditch occurs along the roadside and was constructed and is maintained as a roadside ditch. This feature is not a water of the United States and is a non-relatively permanent water.
