# Lake Texoma Shoreline Management Plan Revision Public Information Meeting

30-day comment period December 02, 2020 - January 02, 2021

The U.S. Army Corps of Engineers has released the draft Lake Texoma Shoreline Management Plan revision. The Shoreline Management Plan revision, which must be compliant with the 2017 Lake Texoma Master Plan, establishes policies and provides guidelines for managing the shoreline (Lakeshore) of Lake Texoma, Texas and Oklahoma for:

- (1) the protection of desirable environmental characteristics
- (2) the restoration of shorelines where degradation has occurred
- (3) update specific rules that apply to certain private actions on public lands and waters, such as boat docks and mowing.

The draft Shoreline Management Plan can be found on the district website below, and a summary of changes can be found within the Shoreline Management Plan, Appendix G. Your input is needed regarding all aspects of the Shoreline Management Plan.
