


# EUFALA LAKE

# HUNTING GUIDE

## EUFAULA LAKE

Hunting at Eufaula Lake is in accordance with applicable federal and state fish and wildlife regulations. Generally, all Corps lands are open to the public for hunting except developed recreational areas and lands around the dam and other structures. Camping is allowed in designated areas only. Hunting is prohibited in all public use areas. Hunters are urged to exercise the basic rules of good sportsmanship, safety, and common sense.

Hunters wishing to obtain current hunting regulations or construct duck blinds on Corps lands should reference the current Oklahoma Hunting Guide or contact the Oklahoma Department of Wildlife Conservation, 1801 N. Lincoln Blvd, Oklahoma City, OK 73105 (405) 521-2739.

Vehicles must remain on established roads. Public lands leased or licensed for private use are also open to public hunting and fishing. The lessee, in order to protect personal property, may be authorized to lock gates or prohibit nonofficial vehicles. However, this in no way prohibits public use of the area or prevents foot access across the land. The lessee or licensee is entitled to compensation from persons causing damage to crops or facilities belonging to them.

## RESTRICTED HUNTING

As the result of cooperative arrangements between the Oklahoma Wildlife Conservation Commission and the Tulsa District Corps of Engineers, several tracts of Corps lands have been made available to sportsmen for restricted hunting. With the exception of the special restrictions outlined below, all provisions of the Oklahoma Hunting Regulations for Corps of Engineers lands are applicable on these areas.

- A. The following areas are open for hunting of all species which may legally be taken during legal open seasons by archery equipment and shotgun with pellets only. Deer hunting is by archery equipment only.

Open for archery equipment 1 October through 28 February and open for Shotguns with pellets from 1 November through 28 February.

- 1) A 165-acre unit in the Highway 31 Landing Area.
- 2) A 128-acre unit in Holiday Cove Recreation Area.
- 3) A 200-acre unit in the Hickory Point Recreation Area.
- 4) A 90-acre unit in the Gentry Creek Recreation Area.

- B. Open for hunting for all species that can be legally taken during legal open seasons by archery equipment and shotguns with pellets, except for the 2<sup>nd</sup> Friday through Monday in December.

- 1) A 395-acre unit in the Brooken Cove Recreation Area.

- C. All other restricted areas shown are open for hunting of all species that can be legally taken during legal open seasons by archery equipment and shotgun with pellets.
