

# HUNTING GUIDE

## LAKE TEXOMA

Hunting at Lake Texoma is in accordance with applicable federal and state regulations. Generally, all Corps hunting areas are open for public hunting of all legal species with the use of any legal weapon for that open season except in areas designated for restricted hunting. Hunting is prohibited in developed recreational areas, lands around the dam and other structures. Vehicles must remain on established roads and camping is allowed in designated areas only. Hunters are urged to exercise the basic rules of good sportsmanship, safety, and common sense.

Hunters wishing to obtain current hunting regulations on Corps lands must contact the Oklahoma Department of Wildlife Conservation, 1801 N. Lincoln Blvd, Oklahoma City, OK 73105 (405) 521-2739 or the Texas Parks and Wildlife Department, 4200 Smith School Road, Austin, TX 78744 (800) 792-1112.

The two National Wildlife Refuges managed by the United States Fish and Wildlife Service on Lake Texoma are: the Hagerman National Wildlife Refuge, an 11,429-acre waterfowl refuge, on the Big Mineral Arm and the Tishomingo National Wildlife Refuge, a 13,450-acre waterfowl refuge, located on the Washita Arm. Both refuges are marked either by buoys or signs. Hunting is restricted to special seasons as determined by US Fish and Wildlife Service personnel. All boating and fishing is restricted on the refuges from 1 October through 31 March. The 3,170-acre Tishomingo Cooperative Wildlife Management Area is open for hunting at specified times during the fall season.

- Check the weather forecast before going to the field.
- Handle every gun as if it were loaded.
- Be sure of your target and what is beyond it.

- Alcohol, boats, and firearms don't mix.
- The use of ATV's on Corps property is prohibited.



## RESTRICTED HUNTING

As the result of cooperative arrangements between the Oklahoma Wildlife Conservation Commission, the Texas Parks and Wildlife Department, and the Tulsa District Corps of Engineers, several tracts of Corps lands have been made available to sportsmen for restricted hunting. With the exception of the special restrictions outlined below, all provisions of the Oklahoma and Texas hunting regulations are applicable on these areas.

The following areas are open for hunting of all species which may legally be taken during legal open seasons by archery equipment and shotguns with pellets only.

- 1) A 380-acre unit below Denison Dam.
- 2) A 160-acre unit in the Willow Springs Area.
- 3) A 100-acre unit in the Buncombe Creek West Area.
- 4) A 110-acre on the Limestone Creek Area.
- 5) A 250-acre unit on the Treasure Island, North Island Group.
- 6) A 512-acre unit in the McLaughlin Creek Southwest Area.
- 7) A 1,110-acre unit in the Washita Point Area.
- 8) A 300-acre unit south of the Butcher Pen Area.
- 9) A 800-acre unit on either side of Highway 70 on the east side of the lake.
- 10) A 650-acre unit in the Lakeside West and South Area.
- 11) A 420-acre unit in the Lebanon Area.
- 12) A 226-acre unit on the west side of Wilson Creek.
- 13) A 130-acre unit in the Caney Creek Area.
- 14) A 170-acre unit in the Oakview North Area.

The following areas are open for hunting of all species which may legally be taken during legal open seasons by **ARCHERY EQUIPMENT ONLY** all firearms are prohibited.

- 1) A 610-acre unit in the Burns Run Area.
- 2) A 500-acre unit in the Alberta Creek Area.
- 3) A 60-acre unit in the Colbert Boat Club Area.
- 4) A 40-acre unit in the Oak Hills Area.
- 5) A 100-acre unit in the Willafa Woods Area.
- 6) A 50-acre unit in the Buncombe Creek South Area.
- 7) All restricted areas shown on the Texas side.

The following areas are open for hunting of all species which may legally be taken during legal open seasons by archery equipment and all legal firearms other than centerfire rifles and handguns.

- 1) A 800-acre unit in the Platter Flats area.
- 2) A 330-acre unit in the Streetman East Area.
- 3) A 400-acre unit in the Newberry Creek South Area.
- 4) A 220-acre unit in the Enos East Area.
- 5) A 115-acre unit in the Island View East Area.
- 6) A 350-acre unit in the Buncombe Creek East Area.
