This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?

Note: the above list of considerations is not inclusive and other functions observed or known to occur should be documented below:

- Significant nexus findings for non-RPW that has no adjacent wetlands and flows directly or indirectly into TNWs. Explain findings of presence or absence of significant nexus below, based on the tributary itself, then go to Section III.D: The subject unnamed tributary of Adams Creek consists of a headwater, first order, ephemeral stream. As such, stream flow is restricted to short periods of time during and immediately following rainfall events. The average yearly precipitation for the subject area is 44.77 inches. The area experiences an average yearly snowfall of 8.1 inches. The total drainage area for the stream order in question is approximately 224 acres. There are no wetlands known to be adjacent or abutting the subject tributary. Ultimately, for the subject stream order to be a jurisdictional water of the United States, a significant nexus must be proven between the subject first order stream and the Verdigris River, which is the nearest traditionally navigable water (TNW). In terms of river miles, the subject stream order is approximately 21 miles from the TNW. In terms of aerial miles, the subject stream order is approximately 10 miles from the TNW. There is a nexus present between the subject first order ephemeral stream and the TNW; however, the onsite beaver (Castor canadensis) pond regulates flow. When the beaver pond releases water downstream the water flows through an underground storm drain, where the tributary has been placed underground as a result of historical development activities, in route to Adams Creek and eventually the Verdigris River. Pollutants consisting of trash (e.g. fast-food cups) appeared to be retained on-site due to regulated water flow facilitated by beavers. Though, upon inspection, no aquatic macroinvertebrates were noted to be present in the stream, evidence of the presence of beavers was abundant in the form of telltale gnaw marks on tree stumps. Beaver ponds, such as the one on the project site, are often indicative of areas experiencing relatively low water currents where sediments and associated nutrients may settle to the bottom. It is reasonable to infer that the beaver activity has resulted in increased evapotranspiration and reduced storm surges. Mineral nutrient fluxes to the Verdigris River are decreased in light of the beaver activity along the subject tributary. These characteristics, including those associated with the beaver activity, serve as evidence to assert that the tributary in question is having a significant effect on the physical, chemical, and biological integrity of the Verdigris River. Based on this evidence for a significant nexus, the subject first order ephemeral stream and its on-channel pond is a jurisdictional water of the United States within the context of current policy.
