C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The proposed project is located in an area of suburban development surrounded on all sides by commercial businesses and residences. One ditch has been identified within the proposed project location. The ditch is visible on aerial photography, but is not indicated on 7.5 minute USGS Topographic maps and connectivity to Waters of the United States could not be identified. Therefore, the ditch is determined to be excavated wholly in the uplands, and not within the Corps jurisdiction, pursuant to Section 404 of the Clean Water Act. The degradation or destruction of the ditch would have no effect on interstate or foreign commerce (per 33 CFR 328.3).
