MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ [SWT-2017-552]

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in this state due to litigation.

1. SUMMARY OF CONCLUSIONS.

3. REVIEW AREA: The review area is approximately 170 acres, (34.124619, -95.369205), near Sawyer, Choctaw County, Oklahoma. The review area is depicted on the associated AJD Map. The review area is adjacent to an existing/on-going rock quarry, and the site drains from East to West.
4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED: The unmapped feature flows indirectly into the Red River, which is both an interstate water as well as a defined Traditionally Navigable Water.
5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS: The unnamed tributary flows into North Fork Holly Creek, then into Hugo Lake (Kiamichi River), then into the Red River.

The unnamed tributary (3,137 linear feet) flows along the southern boundary of the review area and was mapped as an intermittent stream on the USGS map and a riverine feature on the NWI map. The drainage area is approximately 640 acres and an estimated average daily stream flow of 0.27 cubic feet/second. The observed ordinary high-water mark (OHWM) averages 1.5 feet deep with an average width of 6.5 feet. Water flow appears sufficient to maintain stable, well-defined bed and bank features but lacks the frequency and duration to constitute relatively permanent flow. Throughout the review area, the unnamed tributary appears to be an ephemeral, non-relatively permanent water only flowing in response to direct precipitation events. The agent

performed two different site visits which support this flow regime finding. The unnamed tributary is a non-jurisdictional, non-relatively permanent water.
