- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The review area contains two ponds (Pond 11 and 12) that are 0.653 and 0.140 acre in size, respectively. The review area also includes three wetlands (Wetland 10, 11, and 12) that are 0.006, 0.028, and 0.037 acre in size, respectively. The delineation report describes the man-made Pond 11 as artificially impounded with a dirt road and fence line along the west bank and wooded and scrub-shrub habitat > 100 feet wide on the east bank. This feature is not mapped on the 7.5 minute United States Geologic Survey (USGS) topographic map or the National Wetland**

Inventory Map (NWI) and is at a higher elevation than the surrounding habitat. Pond 11 is located outside of the 100-year floodplain and the closest tributary is approximately 200 feet to the west. The delineation report describes Pond 12 as a man-made excavated depression with a small dirt road extending along the west side. This feature is not mapped on the 7.5 minute USGS topographic map or the NWI map and is at a higher elevation than the surrounding habitat. Pond 12 is located outside of the 100-year floodplain and the closest tributary is approximately 130 feet to the west. Wetland 10 is a small palustrine emergent wetland located adjacent to S. 57th W. Avenue and outside of the 100-year floodplain. The closest tributary is approximately 1,070 feet east of the wetland. Wetland 10 is not mapped on the 7.5 minute USGS topographic map or the NWI map. The delineation report describes Wetland 11 as a palustrine scrub-shrub wetland located west and adjacent to Pond 12. This feature is not mapped on the 7.5 minute USGS topographic map or the NWI map. Wetland 11 is outside of the 100-year floodplain and the closest tributary is approximately 80 feet to the west; however, the wetland is at a higher elevation than the tributary and no drainage channel was observed. Wetland 12 is a palustrine scrub-shrub wetland located on a hillslope west and adjacent to Pond 11. This feature is not mapped on the 7.5 minute USGS topographic map or the NWI map. The wetland is outside of the 100-year floodplain and the closest tributary is approximately 85 feet to the west. These features were determined to be isolated in relation to any associated jurisdictional waters that are nearby.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
