2. Non-regulated waters/wetlands (check if applicable):³

- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The review area contains four ponds (Pond 2, 3, 5, and 14) that are 0.158, 0.122, 0.723, 0.161 acre in size, respectively. The review area also includes six wetlands (Wetland 3, 4, 5, 6, 22, and 23) and one intermittent roadside ditch (OW 2) that are 0.078, 0.057, 0.018, 0.003, 0.016, and 0.031 acre in size, and 329.8 linear feet in size, respectively. The delineation report describes Pond 2 as likely a natural feature that is located outside of the 100-year floodplain. This feature is mapped on the 7.5 minute United States Geologic Survey (USGS) topographic map and the National**

Wetland Inventory (NWI) map; however, no outlet for water to exit was observed. Pond 3 is an isolated depression that has been heavily disturbed with recent tree cutting along the perimeter of the pond and activity at the quarry directly south of the pond. The feature is mapped on the 7.5 minute USGS topographic map but is separated from waters of the U.S. by a roadway to the west and a large quarry wall to the south. Pond 3 is located outside of the 100-year floodplain and the closest tributary is approximately 1,000 feet to the west. The delineation report describes Pond 5 as man-made and mostly encompassed by a gravel road with an active blueberry farm to the south. This feature is not mapped on the 7.5 minute USGS topographic map or the NWI map. The closest tributary to Pond 5 is approximately 60 feet to the west. Pond 14 is a man-made bermed depression. This feature is mapped on the 7.5 minute USGS topographic map as well as the NWI map. Pond 14 is located outside of the 100-year floodplain and the closest tributary is approximately 460 feet to the west. Wetland 3 is described as a fringe wetland around Pond 2 that met the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and/or the Midwest Regional Supplement. This feature is mapped on the 7.5 minute USGS topographic map and the NWI map; however, no outlet for water to exit was observed. The closest tributary to Wetland 3 is approximately 1,050 feet to the west. Wetland 4 is located within a detention basin adjacent to and between the existing Gilcrease Expressway and several commercial buildings. This feature is not mapped on the 7.5 minute USGS topographic map or the NWI map. Wetland 4 is located outside of the 100-year floodplain and the closest tributary is approximately 2,100 feet to the west. The delineation report describes Wetland 5 as an emergent wetland that receives water from OW 2 but does not drain into a water of the U.S. This feature is located within the maintained right-of-way and outside of the 100-year floodplain. Wetland 5 is not mapped on the 7.5 minute USGS topographic map or the NWI map. The closest tributary to this feature is approximately 400 feet to the west. Wetland 6 is described as a palustrine emergent fringe on the southwest corner of Pond 5 and met the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and/or the Midwest Regional Supplement. This feature is not mapped on the 7.5 minute USGS topographic map or the NWI map. Wetland 6 is located outside of the 100-year floodplain and the closest tributary to this feature is approximately 60 feet to the west. The delineation report describes Wetland 22 as a palustrine emergent wetland abutting a reinforced concrete box south of the Gilcrease on-ramp in the southern portion of the study area. This feature is not mapped on the 7.5 minute USGS topographic map or the NWI map. The wetland is outside of the 100-year floodplain and the closest tributary is > 1 mile to the southeast. Wetland 23 is described as a palustrine emergent linear fringe wetland around Pond 14 and met the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and/or the Midwest Regional Supplement. This feature is mapped on the 7.5 minute USGS topographic map and the NWI. Wetland 23 is located outside of the 100-year floodplain and the closest tributary to this features is approximately 460 feet to the west. OW 2 is a roadside ditch that begins outside of the study area and flows west approximately 60 feet and goes north approximately 110 feet before turning west under the existing Gilcrease Expressway and terminating into Wetland 5. OW 2 is located within the maintained right-of-way and outside of the 100-year floodplain. This feature is not mapped on the 7.5 minute USGS topographic map or the NWI map. The closest tributary to OW 2 is approximately 400 feet to the west. These features were determined to be isolated in relation to any associated jurisdictional waters that are nearby.

Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This AJD consists of four ponds (Pond 2, 3, 5, and 14) that are 0.158, 0.122, 0.723, 0.161 acre in size, respectively. This AJD also includes six wetlands (Wetland 3, 4, 5, 6, 22, and 23) and one intermittent roadside ditch (OW 2) that are 0.078, 0.057, 0.018, 0.003, 0.016, and 0.031 acre in size, and 329.8 linear feet in size, respectively. These features were included in the aquatic report and determined to not be jurisdictional which is detailed in Section 2(B)(2). These features were determined to be isolated in relation to any associated jurisdictional waters that are nearby.
