Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: **The review area contains two emergent wetlands and one drainage feature. The emergent wetlands exhibited all three characteristics to be defined as a wetland. The drainage feature exhibited a bed and bank. However, aerial photographs did not identify the wetlands or drainage feature prior to the construction of the residential development to the north of the review area. The construction activities associated with the residential development, including road**

construction and removals, resulted in the creation of topographically lower areas, which caused the development of the wetlands. Additionally, the directed hydrologic run off from the constructed residential development caused the creation of the drainage feature. Since the construction activities resulted in the creation of two wetlands and drainage feature, these features are not considered jurisdictional pursuant to Section 404 of the Clean Water Act and are not considered to be Waters of the U.S. pursuant to the Preamble to 33 CFR Parts 320 through 330.

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The construction activities associated with the residential development, including road construction and removals, resulted in the creation of topographically lower areas, which caused the development of the wetlands. Additionally, the directed hydrologic run off from the constructed residential development caused the creation of the drainage feature. Since the construction activities resulted in the creation of two wetlands and drainage feature, these features are not considered jurisdictional pursuant to Section 404 of the Clean Water Act and are not considered to be Waters of the U.S. pursuant to the Preamble to 33 CFR Parts 320 through 330. The unnamed intermittent stream to Mustang Creek exhibited OHWM and bed and bank. Additionally, the tributary was identified on USGS Topographic map, National Wetland Inventory map, the National Hydrologic Dataset map, and in all available years of aerial photography. Therefore, the tributary has been determined to be jurisdictional pursuant to Section 404 of the Clean Water Act.
