Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: **P1 is mapped on USGS topographic map with no connectivity to downstream waters. The delineation report dated June 24, 2021, did not identify any connectivity to downstream waters. Therefore, P1 is determined to be a pond excavated wholly in the uplands and is not jurisdictional pursuant to Section 404 of the Clean Water Act. P2 is not mapped on USGS topographic map. The delineation report dated June 24, 2021, did not identify any connectivity to**

downstream waters. Therefore, P2 is determined to be a pond excavated wholly in the uplands and is not jurisdictional pursuant to Section 404 of the Clean Water Act. S4 and S5 are not mapped on USGS topographic map. During the site visit on 4 APR 2022, S4 and S5 were observed to be located at a higher gradient than P1 and P2, with water flowing from the adjacent roadways with no connectivity to downstream waters. S4 and S5 were determined to be erosional features. Therefore, S4 and S5 were determined not to meet the definition of a tributary and are not jurisdictional pursuant to Section 404 of the Clean Water Act.

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. If the aquatic resource is a wetland directly abutting a tributary with perennial flow, skip to Section III.D.4.

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: W1 acts as a small catchment area for sediments carried via storm water toward the abutting tributary. Sediments and attached nutrients, pollutants, and/or other elements become deposited and captured within the wetland, as opposed to flowing directly to the tributary in question and ultimately to the Arkansas River, a TNW. Due to the wetland's location, the hydrologic conditions, and the diverse vegetation present, the wetlands will host a diverse group of organisms.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

Note: the above list of considerations is not inclusive and other functions observed or known to occur should be documented below:

1. **Significant nexus findings for non-RPW that has no adjacent wetlands and flows directly or indirectly into TNWs.** Explain findings of presence or absence of significant nexus below, based on the tributary itself, then go to Section III.D: S2 is not mapped on USGS topographic map. During the site visit on 4 APR 2022, S2 was observed to contain evidence of OHWM, with a clearly defined channel, containing flowing water, and direct connectivity to S1 (an RPW). S2 carries sediments and attached nutrients, pollutants, and/or other elements to S1, downstream tributaries, and ultimately to the Arkansas River, a TNW, during flooding and rain events. Due to the direct hydrologic connectivity to S1 and the vegetation present along the banks, S2 hosts a diverse group of organisms by providing habitat and food for life cycles of many organisms. Therefore, S2 possesses a significant nexus to the Arkansas River.
2. **Significant nexus findings for non-RPW and its adjacent wetlands, where the non-RPW flows directly or indirectly into TNWs.** Explain findings of presence or absence of significant nexus below, based on the tributary in combination with all of its adjacent wetlands, then go to Section III.D:
3. **Significant nexus findings for wetlands adjacent to an RPW but that do not directly abut the RPW.** Explain findings of presence or absence of significant nexus below, based on the tributary in combination with all of its adjacent wetlands, then go to Section III.D: W1 flows into S1 (an RPW) during flood and other rain events, due to separation by a berm. Therefore, W1 possess a significant nexus to the Arkansas River.

Therefore, S4 and S5 were determined not to meet the definition of a tributary and is not jurisdictional pursuant to Section 404 of the Clean Water Act.**
