This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. This tributary continues being observed beyond the review area further upgradient into its primary drainage area.

Other information on duration and volume: With a typical channel dimension and moderate erosional processes observed within the review area for IS-1, this feature likely supports flows and pooling during the wettest periods of the year.

Explain: No water is visible in IS-1 in aerial imagery, however, during a previous site visit, water was observed within the review area which was stained brown/red consistent with the primary parent material for the soil in the review area.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

1. **Significant nexus findings for non-RPW that has no adjacent wetlands and flows directly or indirectly into TNWs.** Explain findings of presence or absence of significant nexus below, based on the tributary itself, then go to Section III.D: The ephemeral stream (ES-1, 1900 LF) is depicted on the USGS Topographic map as a blue line stream. There is the presence of a visible channel in aerial and confirmed at a previous site visit, the average channel width was 3 feet. During the site visit, no flow was observed. The stream channel throughout most of its headwater was entirely covered with herbaceous vegetation. The drainage area for this feature is approximately 60 acres. ES-1 has a limited riparian corridor, which is approximately 30% of the entire reach at the most down-gradient segment before ES-1 and IS-1 confluence. ES-1 is unlikely to have a localized water table associated due to its limited drainage area. Based on the information included in this evaluation, this stream has been determined to have surface water flowing/pooling only in direct response to precipitation. ES-1 likely performs very few ecological functions based on a lack of in-stream habitat complexity and with such a limited drainage area. ES-2 is very similar to ES-1 with a slightly larger riparian corridor, however, the drainage area for this feature is approximately 35 acres. ES-3 is very limited, with less than 15 acre drainage area and a riparian corridor mostly comprised of Eastern Red Cedar. These ephemeral streams may provide limited benefits to the nearest RPW (IS-1) however, it is unlikely that these functions/benefits equate to a more than speculative or insubstantial benefit to the Arkansas River (TNW), which is approximately 250 river miles from the review area. These NRPW's do not meet the SigNex standard set within the Rapanos Guidance document and is supported within this form..
