Summarize overall biological, chemical and physical functions being performed: The wetland complex is comprised of two wetlands, which are located within the watershed of the jurisdictional determination area and adjacent/abutting the intermittent stream channels within the proposed project area, within the catchment..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project boundary is comprised of two jurisdictional, unnamed tributaries of Adams Creek, the intermittent stream channels flow into Adams Creek which flows into the Verdigris River, a TNW. FS-1 is approximately 1,938 linear feet in length and FS-4 is approximately 228 linear feet in length. There are two wetlands directly abutting RPWs found within the proposed project boundary. FS-5 is approximately 0.06 acres in size and directly abuts intermittent stream channel FS-1. FS-3 is approximately 0.16 acres in size and directly abuts intermittent stream channel FS-4. FS-6 is a non-jurisdictional pond constructed in the uplands likely for the purpose of cattle or livestock watering. FS-7,8,9, & 10 are erosional and depressional features that are not jurisdictional waters of the U.S.
