The emergent wetland is neither abutting, adjacent, or inundated by the nearby (a)(2) Cimarron River in a typical year, thus making it a (b1) exclusion.
ES-2	2.56	acre(s)	(b)(12) Waste treatment system	This is a man-made wastewater treatment lagoon that was constructed in the uplands that is being modified in this action. It doesn't have a hydrological connection to Waters of the US.
ES-3	100	feet	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool	The ephemeral swale contributes flow directly after a significant rain event. The feature does not have an ordinary high-water mark or bed and bank based on photos taken of the sight. The feature also does not appear on USGS topographic maps or USFWS NWI maps.
