While the stream is mapped on the USGS topographic maps as exhibiting intermittent flow, the construction of residential developments within the watershed of the stream has reduced the watershed to the point that the stream now flows only after rain events and is considered an ephemeral stream.

**B. Typical year assessment(s):** The APT was used for both site visit dates. The APT determined that the May 2020 site visit was conducted during normal conditions. During this site visit the stream was found to contain standing water, with no water flowing into or out of the stream. Additionally, culverts downstream were found to contain small amounts of standing water. The APT determined that the October 2020 site visit was conducted during drier than normal conditions. During this site visit the stream was found to contain no water upstream, within the onsite stream, or downstream. This information supports the ephemeral flow determination.
