Delineation, Associated with the Tri-Star Mine, Parts of the SE/4-SW/4 and SW/4-SE/4 in Section 7, Township 19N, Range 26E Adair County, Oklahoma, dated June 2019. The APT result for 12 Jun 2019 was a wetter than normal value of 17; and, the APT result for 13 Jun 2019 was a wetter than normal value of 18.
