Additional comments to support AJD:** Although this ditch is identified on both USGS topographic map and NWI map as a blue line feature, based on site photos and aerial imagery, the feature is clearly constructed to contain storm water around the school building and is a straight grass lined channel which appears mostly dry in various aerial imagery dating from 1995-2018.
