#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Approximately 875 lf of the upper extent of an unnamed tributary of the North Canadian River is located within the review area. When stream flow is present, it would flow south out of the review area through 1,100 lf of concrete box culvert (Hamby Road) and then flow to the confluence of another unnamed tributary of the North Canadian River near Interstate 40, the downstream limit of the relevant reach. The tributary exists the review area through a long culvert under Reno Avenue and Hamby Drive. The tributary within the review area is located within the Zone AE – 100-Year Flood Zone and is indicated on the USGS Topographic Map as an intermittent stream. The National Wetland Inventory Map indicates the tributary as a linear PFO1A. The tributary flows to another unnamed tributary of the North Canadian River which flows for approximately 3,500 lf to the confluence with the North Canadian River. The reach of the tributary within the review area is the former location of the North Canadian River according to historical topographic maps (historicaerials.com – Topo 1893). While the remnant location of the river appears to have remained unchanged within the review area, the source of hydrology has been altered by past development activities to the north, west, and south. The riparian area was previously cleared according to Google Earth imagery between the years 2018 and 2020, however, black willow (FACW in the Great Plains according to the USACE National Wetlands Plant List) was observed within the stream channel for most of the review area. Potential wetlands exist abutting the tributary immediately south of the Hamby Drive culvert. The potential wetlands (Typha spp.) would trap and reduce pollutants from adjacent development stormwater discharges affecting the downstream water quality of the North Canadian River.

#### B. ADDITIONAL COMMENTS TO SUPPORT JD: The review area is approximately 21 acres.

The APT for 30 Sept 2022 returned Mild Drought, Dry Season, and Drier than Normal. The APT for 15 June 2022 returned Incipient Drought, Dry Season, Wetter than Normal provided with the requestor's delineation.
