PUBHh	0.2	acre(s)	(b)(8) Artificial lake/pond constructed or excavated in upland or a non-jurisdictional water, so long as the artificial lake or pond is not an impoundment of a jurisdictional water that meets (c)(6).	Based on USGS topographical maps, aerial imagery, and a site visit, PUBHh does not appear to have been constructed on WOTUS and it's only downstream connectivity is through non-jurisdictional waters. Therefore, PUBHh has been determined to be a non-jurisdictional artificial pond.
EF-1	410	linear feet	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool.	Based on USGS topographical maps, aerial imagery, and a site visit, EF-1 is an unmapped ephemeral stream that only contributes downstream flow in direct response to significant rain events. A site visit was conducted immediately following and during a rain event and there was no flow or pooling. Therefore, EF-1 has been determined to be a non-jurisdictional ephemeral stream.
DF-1	765	linear feet	(b)(5) Ditch that is not an (a)(1) or (a)(2) water, and those portions of a ditch constructed in an (a)(4) water that do not satisfy the conditions of (c)(1)	Based on a site visit and recent aerial imagery, DF-1 is a concrete-lined drainage ditch that was constructed entirely in the uplands to aide in draining overland flow from the constructed roadways. Therefore, DF-1 has been determined to be a non-jurisdictional ditch.
