aerial photography, the lake and dam were not maintained, which resulted in the depressional areas. Upon review of aerial photography, IW3 is a depressional area located in a remanent channel of a mapped stream. Based on historic aerial photography, the stream channel was altered via excavation and channelization between 2010 and 2011, which significantly reduced stream flow, resulting in the eradication of the OHWM. Based on the "Aquatic Resources Delineation Report for a 78-acre Area of the Evers Lake Project in Rogers County, Oklahoma", aerial photography, and topographic maps, IW1, IW2, and IW3 have been determined to be geographically isolated from downstream waters.

Summarize overall biological, chemical and physical functions being performed: The on-site wetlands directly abut the on-site tributaries and impoundments, which contribute flow into and out of the wetland, The water flow exchange provides a route for the exchange of nutrients, gases, and a passage for aquatic species.

# C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
