PUB-1 is a depressional feature located in the uplands that is seasonally inundated by rainfall. The feature is isolated within the uplands and does not contribute flow to an (a)(1)-(a)(3) water and is not inundated by an (a)(1)-(a)(3) water within a typical year. Thus, PUB-1 is a non- jurisdictional feature.		
PEM1-1	0.174	acre(s)	(b)(1) Non- adjacent wetland.	PEM1-1 consists of three (3) emergent wetlands exhibiting similar features that were delineated collectively as PEM1-1. These wetlands are depressional features that are located in the uplands with hydrology being provided by seasonal run-off from the surrounding uplands. PEM1-1 is neither adjacent to or inundated by an (a)(1)-(a)(3) water within a typical year. Thus, PEM1-1, is a non-jurisdictional feature.
