EF-1	480	linear feet	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool.	EF-1 is an ephemeral swale flowing from the northwest corner of the property southeast for approximately 480 linear feet before ending in a storm drain. The feature is entirely grass lined without a discernible bed and bank. Upon investigation it was determined that EF-1 only contributes flow in direct response to rain events. EF-1 is not mapped on USGS topographic maps. Therefore, EF-1 is a non-jurisdictional ephemeral feature.
EF-2	140	linear feet	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool.	EF-2 is an ephemeral swale flowing east from the center of the property for approximately 140 linear feet before converging with EF-1. The feature is entirely grass lined without a discernible bed and bank. Upon investigation it was determined that EF-2 only contributes flow in direct response to rain events. EF-2 is not mapped on USGS topographic maps, NHD, or USFWS Wetland Inventory Maps. Therefore, EF-1 is a non-jurisdictional ephemeral feature.
F-1	110	linear feet	(b)(10) Stormwater control feature constructed or excavated in upland or in a non-jurisdictional water to convey, treat, infiltrate, or store stormwater runoff.	F-1 is a man-made stormwater drainage feature that was constructed in the uplands to convey stormwater from the adjacent development near the southwest corner of the property. F-1, a man-made feature, flows east for approximately 110 linear feet before the channel ends and all flow is converted into overland sheet flow. F-1 is not mapped on USGS topographic maps, NHD, or USFWS Wetland Inventory Maps. Therefore, F-1 is a non-jurisdictional stormwater control feature.
