### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

The PFO1-1 delineated wetland was observed situated to the north, above and separated by a culverted man made road/trail bordering the Stinchcomb Wildlife Refuge and the subject property review area. The USFWS National Wetlands Inventory indicates a Freshwater Forested/Shrub Wetland habitat classified as a PFO1A on the south side of the road/trail and adjacent to the North Canadian River. This wetland receives hydrology from temporary impoundment of storm water and flooding events from the North Canadian River

Per 33 CFR 328.3(c), wetlands separated from other waters of the U.S. by man-made dikes or barriers, natural river berms, beach dunes, and the like are adjacent. Note that a continuous surface connection does not require surface water to be continuously present between the wetland and the tributary.
