SP8003- 55 linear feet (0.002 acre), and SP8004- 90 linear feet (0.005 acre). All 10 of the wetlands within the review area contribute flow to the isolated stream SP8001. Additionally, the 3 ephemeral streams SP8002, SP8003, and SP8004 also contribute flow to SP8001. SP8001 was delineated as a perennial stream that receives its hydrology from all other delineated features within the review area and from runoff from the adjacent refinery that was constructed prior to 1969. None of the aforementioned features are mapped on USGS Topographic, NHD, or NWI Maps. SP8001 originates in the southeast corner of the review area and ends in a culvert that passes below the refinery and is taken into the refinery's on-site water treatment facility, thus isolating all delineated features from contributing flow downstream to navigable waters or interstate commerce. Therefore, all delineated waters within the review area are isolated.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
