This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The Regulatory Office (RO) does not concur with the portion of the delineation report which erroneously lists data points 14 and 16 as occurring in a wetland. Rather, the RO agrees that these data points were located in uplands. Potential streams were assessed within the review area; however, these upland drainage features lacked ordinary high water marks. Decades of work in the area north of the project site have resulted in the new normal circumstances present today; and, this work influences flow characteristics in the area. However, the normal circumstances present in the area today are a result of decades of work history; and, this AJD reflects an assessment of the current normal circumstances – not circumstances which might have existed decades ago. The wetlands and artificial ponds which occur on the project site are surrounded by uplands. Other potential wetlands assessed within the project site do not meet the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and/or appropriate Regional Supplements. No jurisdictional waters of the United States occur within the boundary of this project site.
