During the site visit on May 25, 2021, S1 was observed to have a small amount of flowing water with defined bed and banks. Since the rainfall had been occurring for several days prior to the site visit, the APT shows that the stream is in normal conditions during the wet season, and the stream is not mapped on USGS topographic map, the stream was determined to exhibit no greater than ephemeral flow. |
