#### B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: This emergent wetland likely aids in the filtering of common pollutants found in the drainage area. The wetland may provide limited habitat for aquatic species during the wet period of the year. The wetland likely doesn't provide any other values or functions due to its limited size and complexity.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

This feature is not depicted as a blue line feature on the USGS Topographic map. This feature has been determined as exhibiting ephemeral flow based on the limited frequency and volume of flow anticipated from the 10 acre drainage area. This stream does not have any ground water influence due to the landscape setting (headwater). The review area is comprised of residential homes, mowed pasture, and a riparian corridor along the stream. The stream has an emergent wetland (EW-1, 0.025 ac) abutting the stream. The wetland likely provides limited habitat for aquatic organisms during the wettest time of year. The stream may provide some filtering of any associated pollutants within the drainage area. This stream likely performs very few ecological functions based on a lack of in-stream habitat complexity and with such a limited drainage area. This stream may provide limited benefits to the nearest RPW (unnamed tributary to Lost Creek) however, it is unlikely that these functions/benefits equate to a more than speculative or insubstantial benefit to the Canadian River (TNW), which is approximately 35 river miles from this water. This NRPW and wetland does not meet the SigNex standard set within the Rapanos Guidance document and is supported within the agent's delineation report as well as this form.
