EDF-1	630	linear feet	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool.	EDF-1 is a swale that conveys ephemeral flow and does not exhibit a bed and bank. The feature conveys flow across the western edge of the property into a concrete lined roadside ditch during and immediately after rain events. The APT data shows the day of the site visit was wetter than normal due to increased rainfall. The swale was dry with no sign of recent precipitation or flow.

Therefore, the swale, which exhibited no signs of recent flow during the field visit, has been determined to contain no more than ephemeral flow.](#)
