This area has stormwater routed through the area from upland drainage ditches. The area exhibits sheet flow and has an unnamed tributary adjacent to the review area to the East. This area does not meet the three criteria to be a wetland based on a site delineation and supported by data sheets and site photos.**

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

- Other: (explain, if not covered above): **The review area had the potential for wetlands based on resource maps and its landscape setting adjacent to an unnamed tributary to the North Canadian River, however, the site did not exhibit the three criteria necessary to result in being a wetland. The unnamed tributary was moved around 2002 based on aerial imagery evaluation. This area was excavated prior to the stream being moved adjacent to it. The site did exhibit sheet flow due to stormwater being routed through this forested area into the stream. The lack of hydric soils for every data point within the site is not conclusive that the feature is not a wetland because the site was excavated in the past. Out of 4 data points taken, only one resulted in the plant community meeting the dominance and prevalence criteria, so relying on the vegetation and hydrology factors absent hydric soils is not conclusive that this area is a wetland habitat. Thus this site would not support relying on other data for problematic sites due to previous site disturbances. The feature would be best characterized as a depression excavated in the uplands. This forested area is approximately 11 acres in size.**
