P1 (0.43 acre) was determined to be a non-jurisdictional upland farm pond that was excavated in the uplands and is not an impoundment of jurisdictional waters**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Within the approximately 80-acre review area, there is one jurisdictional water of the U.S. I1 (1,219 linear feet), the unnamed tributary of Bluff Creek, was determined to be a jurisdictional RPW that exhibits a bed and bank, OHWM, and signs of hydrology consistent with that of an intermittent stream channel. I1 contributes flow through the unnamed tributary of Bluff Creek, Bluff Creek, Deer Creek, Cottonwood Creek, the Cimarron River, and the Arkansas River, a Section 10 TNW. Additionally, four non-jurisdictional features were identified within the review area. SW1 was determined to be a non-jurisdictional swale located in the uplands. EF1 was determined to be a non-jurisdictional erosional feature. P1 was determined to be a non-jurisdictional upland farm pond that was excavated in the uplands. EWL1 was determined to be a non-jurisdictional isolated wetland that was created in the uplands as a result of the construction of the man-made pond P1. EWL1 is neither adjacent to or abutting waters of the U.S.
