The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

The unnamed tributary was delineated in the field as a reduced feature downstream of the pond (P-1), which is also depicted on the USGS Topographic map as being an impoundment of the intermittent stream. The pond appears to be constructed in the uplands higher in elevation than the ephemeral tributary (ET-1). The ephemeral tributary has a very limited drainage area, approximately 50 acres. The limited drainage area and landscape setting support that ET-1 has ephemeral flow. ET-1 has a riparian buffer along its left descending bank. ET-1 has an altered channel due to historic land practices, the channel exhibits a very shallow and narrow bed/bank in a straightened path. The altered channel exhibits little to no erosion processes due to the limited drainage area and the pond above it which retains water in the drainage area. ET-1 does not exhibit sufficient field indicators and supporting flow to meet the significant nexus standard. Due to several supporting factors, ET-1 does not meet the significant nexus standard associated with the Eufaula Lake (TNW), which is over 240 river miles away.
