C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Explain findings of presence or absence of significant nexus below, based on the tributary itself, then go to Section III.D: The ephemeral stream (ES-3, 1015 LF) is depicted on the USGS Topographic map as an intermittent unnamed (blue-line) tributary, although it has been demonstrated to exhibit ephemeral flow. ES-3 is the reach of this tributary forming at the confluence of ES-1 and ES-2. This segment of stream is distinct from both ES-1 and ES-2, based on the observation of a continuous bed and bank. The drainage area for this feature is approximately 75 acres. The northernmost portion of ES-3 is a narrow and shallowly-incised feature that is lined primarily by eastern red cedar, persimmon (Diospyros virginiana), and upland grasses. As the feature progresses south (down-gradient), the riparian corridor becomes increasingly populated with eastern red cedar, persimmon and dense stands of bradford pear (Pyrus calleryana) saplings. The stream also begins to demonstrate a more seasonal hydrology as indicated by regular intervals of pooled water and a more deeply incised stream channel with an OHWM estimated at 4 feet in width and demonstrates a consistent bed and bank. ES-3 likely performs various ecological functions based on in-stream habitat complexity, a riparian corridor. ES-3 provides benefits to the nearest RPW and these functions/benefits contribute to the Canadian River (TNW), which is approximately 100 river miles from the review area. ES-3 meets the SigNex standard set within the Rapanos Guidance document and is supported within this form.

ES-1 (1315 LF) is not depicted on the USGS Topographic map as a blue-line tributary. During a site visit, no flow was observed. ES-1 is mostly covered with herbaceous vegetation, and many areas lack a bed/bank entirely. ES-1 has no riparian corridor, however, there are many eastern red cedars in close proximity. ES-1 has a very limited drainage area (12 AC) and has an approximately 4% slope. Based on the information included in this evaluation, this unmapped feature has been determined to have surface water flowing/pooling only in direct response to precipitation. ES-1 likely performs very few ecological functions based on a lack of in-stream habitat complexity and with such a limited drainage area. ES-2 (606 LF) is depicted as the headwater to a blue line tributary on the USGS Topographic Map, however, its flow regime is ephemeral. ES-2 lacks a bed/bank and is best characterized as a swale, with most of it being covered in grass and no confined channel. ES-2 flows out of a pond at the uppermost reach of the headwater for this drainage area (15 AC). ES-2 has no riparian corridor associated with it, and no water was observed. These ephemeral streams (ES-1, ES-2) may provide limited benefits to the nearest RPW, however, it is unlikely that these functions/benefits equate to a more than speculative or insubstantial benefit to the Canadian River (TNW), which is approximately 100 river miles from the review area. These NRPW's (ES-1, ES-2) do not meet the SigNex standard set within the Rapanos Guidance document and is supported within this form.
