Explain: **Within the review area, PUB-1 (2.4 acres) was determined to be non-jurisdictional livestock pond that was constructed in the uplands and was not an impoundment of waters of the U.S. DF-1 (1,150 linear feet) was determined to be a non-jurisdictional ephemeral drainage feature that is grass lined, lacking an OHWM, bed and bank, and hydrology consistent with that of an ephemeral stream. B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). This is most prevalent where agricultural practices are ongoing on both sides of the channel. This erosion, although still present in many portions, appears to dissipate downstream as the stream proceeds through the forested riparian corridor.

Describe flow regime: R4SB-1 is an intermittent stream channel that was flowing at the time of the applicant provided delineation. R4SB-1 was also observed to inhabit several *Corbicula fluminea* valves and few *Gambusia affinis*, thus supporting that R4SB-1 flows seasonally.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

ADDITIONAL COMMENTS TO SUPPORT JD: The review area is approximately 120 acres and contains one jurisdictional relatively permanent water (R4SB-1) that is best described as an intermittent stream channel with flow occurring seasonally. The review area also contains three non-jurisdictional features (PUB-1, DF-1, EF-1). PUB-1 was determined to be a non-jurisdictional livestock pond that was constructed in the uplands and was not an impoundment of waters of the U.S. DF-1 (1,150 linear feet) was determined to be a non-jurisdictional ephemeral drainage feature that is grass lined, lacking an OHWM, bed and bank, and hydrology consistent with that of an ephemeral stream. EF-1 (530 linear feet) was determined to be a non-jurisdictional erosional feature that is grass lined with areas of erosion occurring throughout. EF-1 lacks an OHWM, bed and bank, and hydrology consistent with that of an ephemeral stream. Neither DF-1 or EF-1 are mapped on USGS Topographic, NHD, or USFWS NWI Maps.
