B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: The forested wetland W-2 likely provides limited water quality benefits due to nutrient cycling, filtration, and reducing flood water energy associated with S-1. The wetland supports water table recharge, as well as providing seasonal aquatic habitat for aquatic species.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

1. **Significant nexus findings for non-RPW that has no adjacent wetlands and flows directly or indirectly into TNWs.** Explain findings of presence or absence of significant nexus below, based on the tributary itself, then go to Section III.D: Stream S-2 has been determined as an NRPW and is not depicted on the USGS Topographic Map.. Due to this stream being in a region of greater rain events per year, this stream may exhibit a higher frequency of flow events if it receives direct rain fall, this stream is not likely to be influenced by ground water based on its landscape setting within the uplands. This stream likely does not provide measureable benefits to Panther Creek; it is unlikely that these benefits equate to a more than speculative or insubstantial benefit to the Red River (TNW), which is over 25 river miles from this water. This stream has a very small drainage area of approximately 40 acres. This ephemeral stream may provide some reductions in peak flood flows going into Panther Creek; however, this is speculative in nature. This NRPW does not meet the SigNex standard set within the Rapanos Guidance document and is supported within the agent's delineation report as well as this form.
2. **Significant nexus findings for non-RPW and its adjacent wetlands, where the non-RPW flows directly or indirectly into TNWs.** Explain findings of presence or absence of significant nexus below, based on the tributary in combination with all of its adjacent wetlands, then go to Section III.D: Stream S-1 has been determined as an NRPW and is not depicted on the USGS Topographic Map. The tributary has an associated wetland (W-2) which is adjacent to the tributary. W-2 wetlands is a forested wetland. This ephemeral stream has a bed/bank and is approximately 4 feet wide and 1 foot deep. This tributary forms within the review area and flows north eventually into Panther Creek. The wetland occurs along the riparian buffer of the stream. W-2 likely provides limited wildlife habitat during the spring rain season. This ephemeral stream along with its wetland may provide some reductions in peak flood flows going into downstream waters. This stream has a riparian corridor throughout the review area, thus would contribute organics/nutrients to downstream waters. The water quality is likely suitable for supporting aquatic organisms, due to the limited sources of pollutants which could influence this tributary and its downstream waters. This stream and wetland may likely provide limited benefits to Panther Creek; however, it is unlikely that these functions/benefits equate to a more than speculative or insubstantial benefit to the Red River (TNW), which is over 25 river miles from this water. This NRPW and wetland do not meet the SigNex standard set within the Rapanos Guidance document and is supported within the agent's delineation report as well as this form.
