The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

1. **Significant nexus findings for non-RPW that has no adjacent wetlands and flows directly or indirectly into TNWs.** Explain findings of presence or absence of significant nexus below, based on the tributary itself, then go to Section III.D: Stream S-8 is not depicted on the USGS Topographic Map, and has been determined as an NRPW at the upper headwater. The ephemeral flow transitions to intermittent flow where another non-mapped drainage feature contributes supplemental flow from a golf course. This feature is likely a constructed channel as part of historic military development. Due to this stream being in a region of greater rain events per year, this stream may exhibit a higher frequency of flow events if it receives direct rain fall, this stream is not likely to be influenced by ground water based on its landscape setting (headwater) within the uplands. This stream has a very small drainage area of approximately 15 acres. This stream likely does not provide measureable benefits to Panther Creek via the unnamed tributary which it flows through; thus is unlikely to result in benefits that equate to a more than speculative or insubstantial benefit to the Red River (TNW), which is over 25 river miles from this water. This NRPW does not meet the SigNex standard set within the Rapanos Guidance document and is supported within the agent's delineation report as well as this form.
