Explain: **The review area identified in the May 24, 2022 "Lake Wister Water Treatment Plant, Backwash Lagoon Construction Site" contains two drainages and two wetlands. R6-1 is a 73LF drainage feature with an ordinary high water mark (OHWM) width of 4 feet, R6-2 is drainage feature 283LF feature with an OHWM width of 4 feet. PFO1-1 is a 0.049ac depressional wetland and PEM1-1 is a 0.103ac roadside ditch. PFO1-1 is located in a depression with a**

roadside berm located on the south side of the wetland and exhibits all three characteristics of a wetland (hydric soils, hydrophytic vegetation, and hydrology). However, PFO1-1 was found not to connect or provide flow to downstream waters. R6-1 was identified as a drainage, which provides a flow conveyance for hillside run off and terminates in PFO1-1. 1955 historic aerial imagery indicates that R6-1 is a short historical drainage ditch associated with a historical roadway. Since R6-1 and PFO1-1 do not provide flow to downstream waters, R6-1 and PFO1-1 have been determined to be isolated. R6-2 is located along the road and is determined to be a roadside ditch. PEM1-1 exhibits all three characteristics of a wetland (hydric soils, hydrophytic vegetation, and hydrology). PEM1-1 is located within roadside ditches and downhill from the culvert, therefore PEM1-1 has been determined to be a roadside ditch. Topographic maps and National Wetland Inventory maps did not indicate any mapped waters within the review area. Based on Historical photos, NWI maps, and onsite investigation R6-1, R6-2, PFO1-1, PEM1-1 are created in the uplands due to site changes, such as road construction. Therefore, R6-2 and PEM1-1 have been determined to be roadside ditches and not jurisdictional pursuant to Section 404 of the Clean Water Act. R6-1 has been determined to be an erosional feature. Additionally, PFO1-1 has been determined to be an isolated wetland with no connectivity to downstream waters. Therefore, PFO1-1 is not jurisdictional pursuant to Section 404 of the Clean Water Act.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

PEM1-1 exhibits all three characteristics of a wetland (hydric soils, hydrophytic vegetation, and hydrology). PEM1-1 has been determined to be a roadside ditch. "Wister Water Treatment Plant Backwash Lagoon Construction Site" Delineation Report dated May 24, 2022, Topographic maps and National Wetland Inventory maps did not indicate any mapped waters within the review area. Based on the delineation report, historical photos, NWI maps, and onsite investigation R6-1, R6-2, PFO1-1, PEM1-1 are created in the uplands due to site changes, such as road construction. Therefore, R6-2 and PEM1-1 have been determined to be roadside ditches and not jurisdictional pursuant to Section 404 of the Clean Water Act. R6-1 has been determined to be an erosional feature. Additionally, PFO1-1 has been determined to be an isolated wetland with no connectivity to downstream waters. Therefore, PFO1-1 is not jurisdictional pursuant to Section 404 of the Clean Water Act.**
