Explain: **Within the review area, three ephemeral drainages, R6-1 (432 linear feet), R6-3 (483 linear feet) and R6-4 (413 linear feet) were observed. R6-3 and R6-4 are erosional features that convey sheetflow across the landscape without a discernible ordinary high water mark. Two, non-jurisdictional upland stock tanks were observed within the review**

**area also. PUB-3 (0.310 acre) and PUB-4 (0.161 acre) were man-made impoundments constructed in the uplands, and are not impoundments of jurisdictional waters.**

#### B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

Explain: No flow was observed at the time a site visit was conducted. The stream channel had a healthy forested riparian area. No evidence of pollution was observed.

Wetland type. Explain: Emergent wetlands PEM1-1 (1.055 acre) and PEM1-2 (0.168 acre) were observed within the review area, as well as forested wetlands PFO1-1 (0.109 acre) and PFO1-2 (0.098 acre).

Wetland quality. Explain: Each wetland observed appeared stable and functioning properly. PEM1-2 and PFO1-2 are likely the result of a neighboring development's stormwater retention facility outfall.

Project wetlands cross or serve as state boundaries. Explain: N/A.

(b) General Flow Relationship with Non-TNW:

Flow is: **Intermittent flow**. Explain: PEM1-1 and PFO1-1 are located upstream of jurisdictional impoundment PUB1-1. These features likely retain water seasonally on an annual basis. PEM1-2 and PFO1-2 likely receive ephemeral flow following rain events and are fed by a neighboring development's stormwater retention facility. During periods of heavy precipitation, water likely flows over the outfall structure into PEM1-2 and PFO1-2.

Ecological connection. Explain: PEM1-2 and PFO1-2 are located in close physical proximity to R6SB-1. Aquatic organisms likely move between R6SB-1 and PEM1-2 and PFO1-2 during periods of little or no stream flow utilizing these wetlands as habitat.

Water color was fairly clear.

Summarize overall biological, chemical and physical functions being performed: Each of these wetlands act as a small catchment area for sediments carried via storm water toward the adjacent or abutting tributary as well as habitat for aquatic organisms, migratory birds, and other wildlife. Sediments and attached nutrients, pollutants, and/or other elements become deposited and captured within the wetland, as opposed to flowing directly into R6SB-1 and ultimately to the Arkansas River. Wetlands have been documented as having the capability of providing a long-term sink for nutrients present within waste, pesticides and fertilizers, primarily through their biogeochemical cycling (Walbridge and Lockaby 1994, Axt and Walbridge 1999). Due to this function, wetlands have long been termed the "kidneys of the landscape", due to their capacity to assist with pollutant filtration (Mitsch and Gosselink 2000). Because of the wetland's fluctuating hydrologic conditions, they likely host a variety of organisms dependent upon this type of system.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?

1. **Significant nexus findings for non-RPW that has no adjacent wetlands and flows directly or indirectly into TNWs.** Explain findings of presence or absence of significant nexus below, based on the tributary itself, then go to Section III.D:
2. **Significant nexus findings for non-RPW and its adjacent wetlands, where the non-RPW flows directly or indirectly into TNWs.** Explain findings of presence or absence of significant nexus below, based on the tributary in combination with all of its adjacent wetlands, then go to Section III.D: The subject ephemeral stream (R6SB-1) drains approximately 550 acres and provides storage and filtration during precipitation events. It has been determined that the unnamed ephemeral non-Relatively Permanent Water (non-RPW) possesses hydrologic connectivity to the Arkansas River (Traditional Navigable Water) into which they indirectly flow. Hydrologic connectivity refers to the flow that transports organic matter and nutrients, energy, and aquatic organisms throughout the system (Freeman et al. 2006). Evidence of this connection and, consequently, a significant nexus is



supported by the observations and scientific literature in the following paragraphs. The unnamed non-RPW possesses features of ephemeral tributaries with ordinary high water marks (OHWMs). Features which indicate the presence of an OHWM include a defined bed and bank, a natural line impressed on the bank, vegetation matted down or absent and disturbed leaf litter. Solid organic matter (OM), such as leaves and other detrital material, is processed by a feeding group referred to as "shredders", which includes crayfish, larvae of crane flies, caddisflies, and nymphs of stoneflies. Shredders break down this coarse material, and allow the material to be utilized by a secondary group known as "collectors". Collectors further process the OM and produce dissolved OM and fine particulate matter, which flow downstream. Generally, as the solid OM is processed and translocated downstream, so are the microorganisms and invertebrates which utilize the material (Smith and Smith 2001). As such, headwater tributaries like these R6SB-1 represent the base of the food chain and, therefore, comprise one of the most important components of a watershed (Meyer et al. 2007). That is, the diversity of aquatic fauna in this headwater stream contributes to the biodiversity of Posey Creek and the Arkansas River by fitting into the complex foodweb of the river basin. Furthermore, the frequency of major rainfall events in the watershed results in pulsating hydrology, which sustains the local waterways, and subsequently, the Arkansas River system. This influences the chemistry of the Arkansas River basin via the transport of sediments and nutrients and geochemical cycling which occur during these pulses. After water is conveyed through the tributary, drying occurs in the headwater stream. This process of drying produces natural chemical and physical changes in the headwater stream. According to Izbicki (2007), even while headwater streams are drying, they remain an integral part of the overall stream because of this influence on the chemistry of the river downstream. Finally, headwater streams have been documented as providing necessary habitat for birds, mammals, reptiles, and amphibian populations (Meyer 2007). The small catchment area of headwater streams results in some of the most diverse habitats within a lotic system. Since the channels are greatly affected by precipitation events, the physical and chemical state of the streams change rapidly and frequently which allows the habitat to be utilized by a large variety of species. Headwater streams are utilized not only by species which are unique to headwater streams, but also by animals which depend on such an environment for certain stages of their life cycles and those which migrate between headwater environments and larger waters. R6SB-1 possesses a hydrologic connection to Posey Creek and, subsequently, to the Arkansas River through an open and defined channel. Due to this hydrologic connection, the unnamed tributary has the capacity to contribute hydrology, carry pollutants, provide habitat for aquatic life cycles, and provide food in the form of organic matter to waters downstream, all of which illustrates that the unnamed non-RPWs possess a significant nexus to Posey Creek and the Arkansas River. Abutting wetlands PEM1-1 and PFO1-2 possess a hydrologic connection to the Posey Creek and ultimately the Arkansas River through an open and defined channel. Due to this hydrologic connection, R6SB-1 has the capacity to contribute hydrology, carry pollutants, provide habitat for aquatic life cycles, and provide food in the form of organic matter to waters downstream, all of which illustrates that the non-RPW and the adjacent wetlands possess a significant nexus to the Arkansas River. Adjacent wetlands, PEM1-2 and PFO1-2 provide an ecologic connection to the non-RPW and ultimately the downstream TNW due to the close proximity on the landscape to the non-RPW and a surface connection through PUB-2. Multiple aerial images show a continuous flow path through from the wetlands through PUB-2 into R6SB-1. PEM1-2 and PFO1-2 also provide sustainable aquatic habitat for crayfish, frogs, and other macro invertebrates. Because of the wetland's fluctuating hydrologic conditions, they host a variety of organisms dependent upon this type of system. Given that the wetland is located in a fairly rural environment, it provides habitat for a variety of species also adapted to this type of area. The wetlands have the capacity to physically affect the conditions of the adjacent tributary through their ability to store storm water in times of heavy rain events. Grass and leaf litter, and other organic materials also assist with slowing the flow of water and aiding with trapping sediments. By reducing the volume and velocity of storm water entering the adjacent tributary, the wetland minimizes the erosive forces of the storm water. By reducing the volume and velocity of flow, erosion potentials decrease and sediment transport downstream becomes minimized. This affects Posey Creek, and subsequently the Arkansas River, by reducing sediment input and erosion within these waters.
