Explain: **Within the review area there are two non-jurisdictional features that have been identified. R6-1 (0.012 acre/128 lf) is an erosional feature that collects storm water from the surrounding uplands and PUB-1 (0.525 acre) is a man-made pond constructed wholly in the uplands that has no hydrologic connection to jurisdictional waters. PUB-1 was likely created to provide water for livestock.**

(iii) Chemical Characteristics:

Explain: Defined stream bed and stream banks, distinct change in vegetation, visible saturation within the stream bank soil column and drift lines/debris deposits were used to determine the ordinary high water mark (OHWM) associated with any aquatic resource. The substrate of R4SB-1 was dominated by silt, sand, clay, gravel and cobble surrounded by a mature, forested, riparian corridor. Evidence of localized flooding was observed within the surrounding riparian corridor. Limited aquatic macroinvertebrate diversity, few aquatic isopods, was observed on riffle habitat. R4SB-2 exhibited similar characteristics compared to R4SB-1; however, the forested canopy was limited and significant cattle activity was observed all along the stream channel..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
