MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime  
Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322  
(2023),<sup>1</sup> SWT-2024-00201

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>2</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>3</sup> For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),<sup>4</sup> the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States,'" as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in Oklahoma due to litigation.

3. REVIEW AREA. The review area containing R6SB-1 is approximately 7 acres. The review area containing PUB-2 and PUB-3 is 1 acre. Both review areas are located in the Northeast ¼ of Section 34, Township 14 North, Range 4 West, in Oklahoma County, Oklahoma. The review areas are located near Latitude 35.652213, Longitude -97.609370.

4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. R6SB-1 - Cimarron River – Interstate Water.

5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS

R6SB-1 would flow to an unnamed tributary of Bluff Creek, through Bluff Creel, to Cottowood Creek, to the Cimarron River. There is no flow path for PUB-2 and PUB-3.

PUB-2 and PUB-3 are upland depression areas that are not indicated on the USGS Topo Map, USGS NHD, or USFWS NWI map as features. Additionally, the requestor’s delineation indicated hydric soils were not present necessary to meet the definition of a wetland.

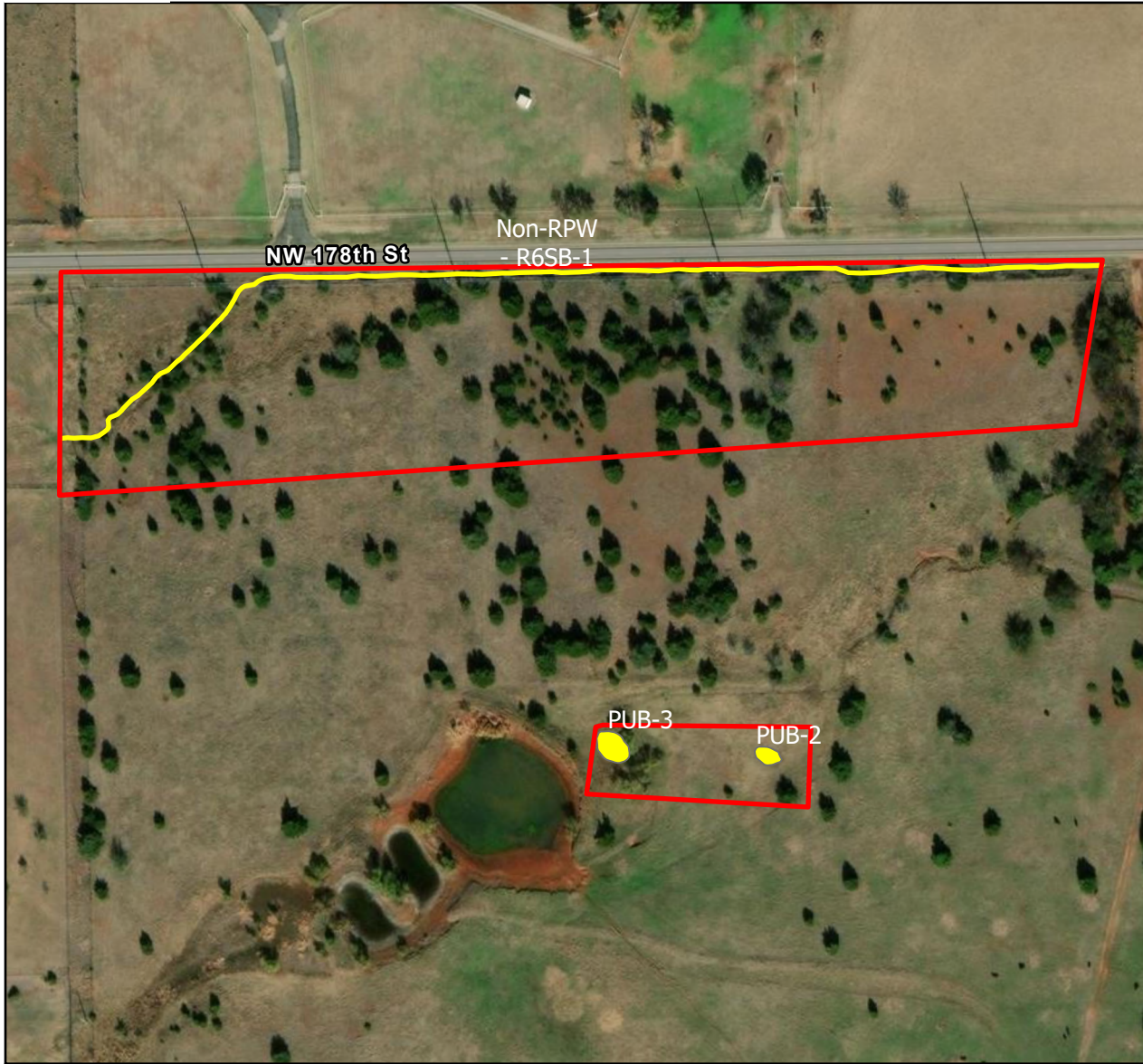
The feature denoted as R6SB-1 in the requestor's delineation is a non-RPW drainage feature that is not depicted on the USGS Topo Map and USGS NHD that for the majority of the feature length, occurs parallels the roadway NW 178<sup>th</sup> Street.
