MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ **SWT-2024-00385 (Choctaw Nation Housing, Hugo, Oklahoma)**.

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States,'" as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in this state due to litigation.

1. SUMMARY OF CONCLUSIONS.

- a. The review area is comprised entirely of dry land (i.e., there are no waters such as streams, rivers, wetlands, lakes, ponds, tidal waters, ditches, and the like in the entire review area and there are no areas that have previously been determined to be jurisdictional under the Rivers and Harbors Act of 1899 in the review area).

Project site consists of an approximately 9-acre review area, located within northwest Hugo, Oklahoma. The review area contains relatively flat pastureland with one unnamed roadway/driveway in the far eastern section of the site.

The review area does not contain any US Geological Survey (USGS) National Hydrology Dataset (NHD) blue line features, denoting likely linear aquatic resources, or mapped wetlands, marsh, or other special aquatic sites. Additionally, the review area does not contain any US Fish and Wildlife Service (USFWS) National Wetland Inventory mapped wetlands or linear aquatic resource.

Outside of the review area is a housing development (south), partially developed lot (north), and undeveloped lots (west and east). No apparent aquatic resources are present to the north or south of the review area. Headwaters to Horse Creek (west) and a large pond (east) are present on the adjacent undeveloped lots.

Per Google Earth open-source aerial imagery: in 1996 the review area was undeveloped agricultural-use land with one upland pond within the south-central portion of the review area; sometime between 1996 and 2003 six furrows (swales) were excavated in the northern segment of the review area, in a northwest-to-southeast orientation, for agricultural use. Between 2015 and 2020 a housing development with an associated road was developed within and south of the review area, which resulted in the filling of the on-site pond and two of the furrows (swales).

The applicant provided a site delineation, which shows that the entire site is upland prairie land with the remnants of the aforementioned furrows (swales), which did not contain OHWM and bed and banks. The swales are the lowest areas of the site.

3. REVIEW AREA: The review area consists of an approximately 9-acre project site east of and adjacent to Airport Road, within northwest Hugo, Choctaw County, Oklahoma (Lat: 34.0243, Long: -95.5358).
4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. Red River, 6.5 miles southwest of project site. Project site is not hydraulically connected to a TNW.⁵

consistent with the naming convention used in section 1, above.
