MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime  
Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322  
(2023),<sup>1</sup> SWT-2024-413

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>2</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>3</sup> For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),<sup>4</sup> the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States,'" as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in this state due to litigation.

3. REVIEW AREA: The two review areas are approximately 33 acres, at site 1 (36.378090, -97.754724), and site 2 (36.382315, -97.764249), in Garfield County, Oklahoma. The review area is identified on the associated AJD Maps.
  4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED.: The Cimmaron River is the nearest interstate water based on this river crossing state borders.
  5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS: The ephemeral tributary flows through 2 other unnamed tributaries, then into Skeleton Creek, which then flows into the Cimmaron River (interstate water). The flow path from the ephemeral headwater to the Cimmaron River is over 60 river miles.

The stormwater pond (1.78 acres) was excavated/diked within the uplands to manage upland runoff for the associated industrial site. The feature is not mapped on any resource maps. The feature meets the definition of a pre-amble, generally non-jurisdictional water.

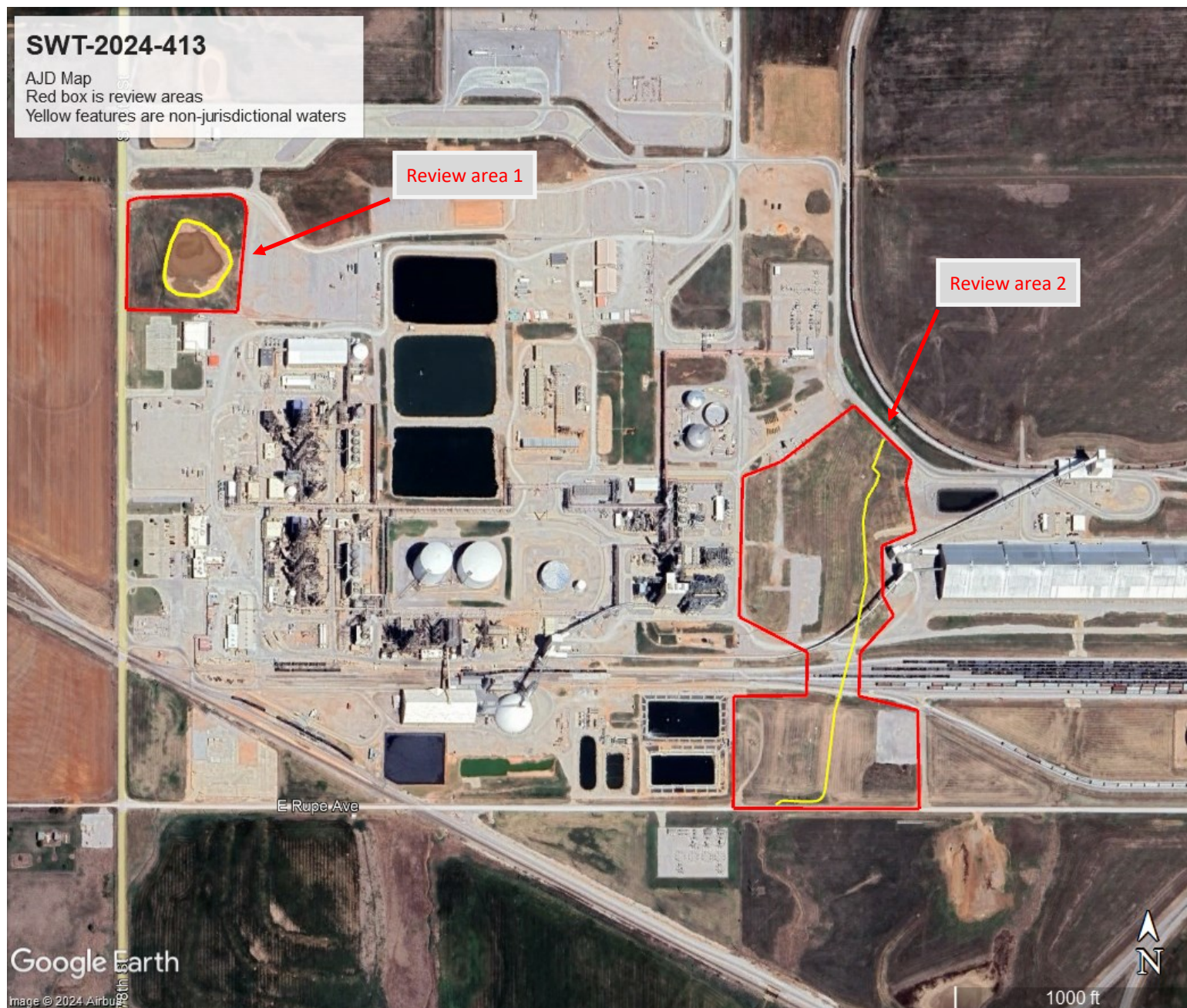
SUBJECT: Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023), (SWT-2024-413)

The ephemeral tributary is at the headwater of an overall mapped unnamed tributary on the USGS Topographic and NWI maps. At this landscape setting this tributary is ephemeral in nature based on its limited water catchment size of approximately 22 acres. The reach of the headwater is approximately 1.8 miles in total where another first order stream meets this tributary. Within the review area this first order stream is approximately 1,800 linear feet. Based on the supporting information, this unnamed tributary to Skeleton Creek is a non-relatively permanent water, thus, also non-jurisdictional.

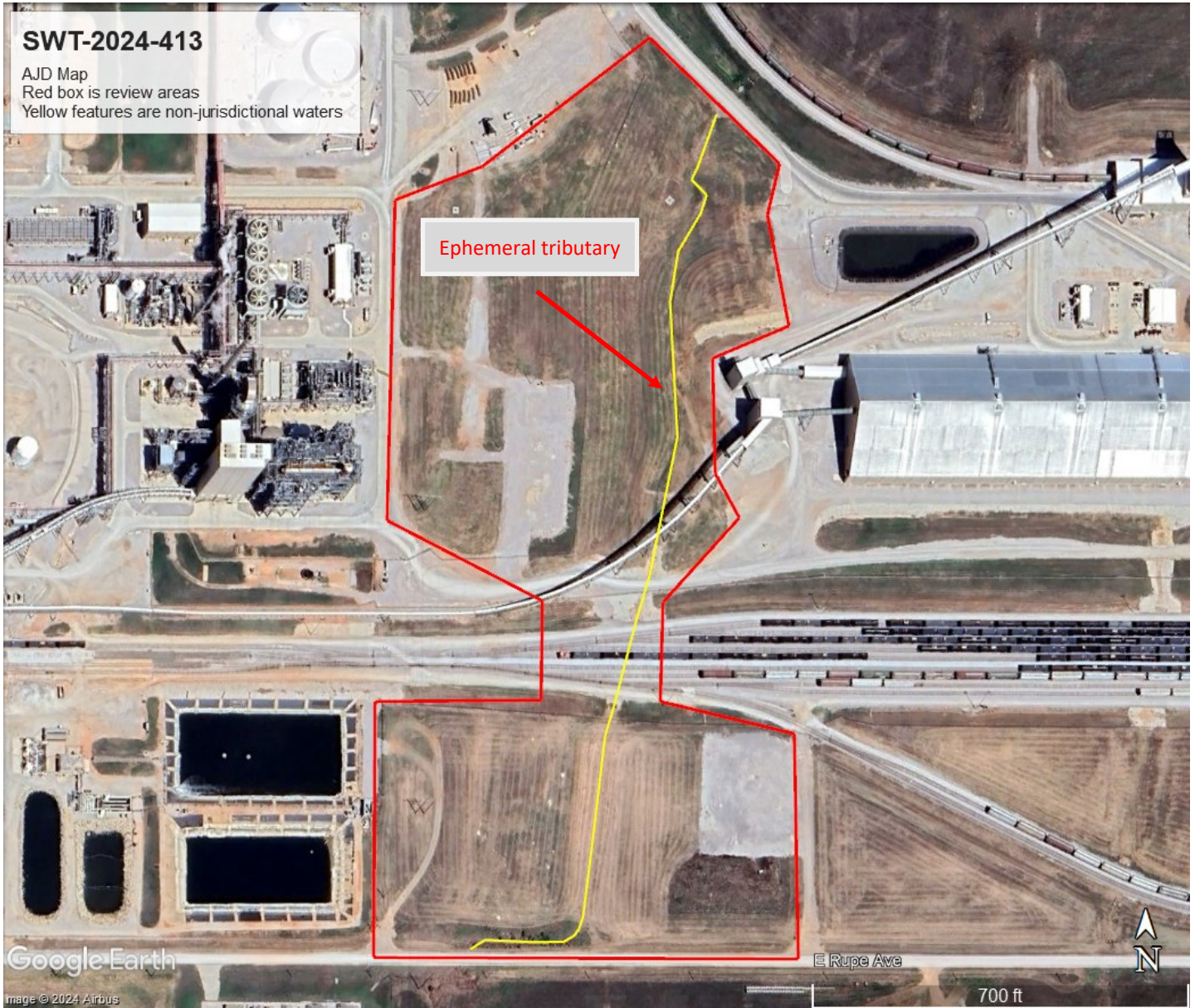


(Figure 2) ( SWT-2024-413) (36.378090, -97.754724) Review area 1, Google Earth aerial imagery dated April 20, 2024.
