MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ [SWT-2024-423]

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in this state due to litigation.

1. SUMMARY OF CONCLUSIONS.

3. REVIEW AREA: The two review areas are approximately 33 acres, at (35.01254, -96.16272), (35.01254, -96.16272), in Oklahoma County, Oklahoma. The review area is identified on the associated AJD Maps.

4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED.: The unnamed tributary eventually flows into the Cimarron River, which is an interstate water due to it crossing state lines.

5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS: The unnamed tributary flows into Spring Creek, then into Cottonwood Creek, then into the Cimarron River approximately 26 miles downstream.

The pond is depicted as being constructed up-gradient of the mapped blue line feature on the USGS Topographic map. This pond was excavated/diked in the uplands. This pond has an approximate 10-acre watershed. This pond is non-jurisdictional.

- b. Describe aquatic resources and features within the review area identified as “generally not jurisdictional” in the *Rapanos* guidance. Include size of the aquatic resource or feature within the review area and describe how it was determined to be non-jurisdictional under the CWA based on the criteria listed in the guidance.

The swale is downstream of the pond within the review area. This feature is depicted on the USGS Topographic and NWI maps as the headwater of an unnamed tributary to Spring Creek. This feature has a watershed of approximately 12 acres. This feature is entirely grass lined and has no defined bed/bank and lacks an ordinary high-water mark. This swale lacks sufficient flow regime to support even ephemeral flow regime.

The ditch was constructed above the pond and drain upland runoff from a nearby roadway. This feature was constructed in the uplands and drains only uplands. This ditch has less than a 10-acre watershed and lacks sufficient flow to result in even ephemeral flow regime. This ditch is non-jurisdictional.
