MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime
Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322
(2023),¹ [SWT-2024-600]

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States,'" as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in this state due to litigation.

1. SUMMARY OF CONCLUSIONS.

3. REVIEW AREA. The 10-acre review area is located in Section 28, Township 13 North, Range 1 East, northeast of the intersection of East Britton Road and the Kickapoo Turnpike, near Jones, Oklahoma County, Oklahoma. Center Coordinates are Latitude: 35.56972, Longitude: -97.19976.

4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED: Lake Eufaula (TNW).

5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS: ES-1, a first order stream, and the associated pond flow northeast offsite for approximately 0.6 miles before reaching the confluence of Wildhorse Creek (RPW). Wildhorse Creek flows mostly north for approximately 7.4 miles into the confluence of the Deep Fork River (RPW). The Deep Fork continues for more than 150 miles before reaching Lake Eufaula (TNW).

ES-1 (500 linear feet) is mapped as an intermittent unnamed tributary of Wildhorse Creek based on the USGS Topographic map and NWI data. ES-1 is a first order (headwater) feature within the review area, until its confluence with Wildhorse Creek outside of the review area. ES-1 exhibits several indicators of a non-RPW, primarily that of ephemeral flow characteristics. Within the review area, ES-1 exhibits no discernable bed and bank with an OHWM upstream and downstream of Pond-1. The channel morphology is characterized as a flat, swale, which is fully grass lined by upland grasses. The report states that these grasses are undisturbed and are routinely mowed. This feature is a Non-RPW, and non-jurisdictional.

Pond 1 (0.6 acre) is mapped as an impoundment of (ES-1) and occurs within the center of the review area. The pond appears to have been partially excavated, but also includes an earthen dam structure with no discharge pipe/outlet. Instead, a dedicated earthen spillway on the east side of the impoundment appears to have been constructed to divert water away from the dam, then to the northeast and off the property. The waters report states there was no indication that surface water flow occurs from the spillway. Furthermore, there was no indication of any outflow on the downstream side of the pond. Both the spillway and the downstream side of the pond were vegetated with regularly maintained upland grasses and there were no changes in vegetation composition or indications of erosional features. This feature does not meet any criteria as a jurisdictional water and is an impoundment of a Non-RPW.
