MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023), 1 SWT-2025-00149

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in Oklahoma due to litigation.

- 3. REVIEW AREA. The review area is approximately 19 acres and can be found at Latitude 35.542779, Longitude -98.696305, in Custer County, Oklahoma.
- NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. Canadian River, Interstate Water of Texas and Oklahoma
- FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS. The unnamed tributary of Little Deep Creek flows to Little Deep Creek, to Deer Creek, then to the Canadian River.

 - e. Tributaries (a)(5): The delineated feature denoted as S1 is located near the upper most extent of an unnamed tributary of Little Deep Creek. It is indicated on the USGS Topographic Map and USGS NHD as part of an intermittent stream (altered in the past from the map depicted alignment within the review area) with a 6-foot-wide channel bed and 8- foot tall, sloping bank walls. Within the review area, there is approximately 1,537 linear feet, with an additional 10,600 linear feet of the tributary located downstream to the confluence with Little Deep Creek. USGS Stream Stats indicates a contributing drainage area of 1,638 acres and an average daily streamflow of 0.946 cfs for the overall reach of the tributary. Hydrology is evident within the stream channel for over half the overall tributary's length on available aerial imagery, from the downstream confluence with Little Deep Creek to north of I-40. According to the Antecedent Precipitation Tool for the August 2024 delineation timeframe, the tool indicated a mild drought, dry

season, and normal conditions. The S1 feature within the review area is a part of a longer reach of the unnamed tributary of Little Deep Creek, a relatively permanent water.
