MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),<sup>1</sup> SWT-2025-166

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>2</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>3</sup> For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),<sup>4</sup> the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in this state due to litigation.

3. REVIEW AREA: The review area is comprised of 3 different areas, review area #1 is approximately 7 acres, Review area #2 is approximately 1 acre, and review area #3 is approximately 5 acres. All three review areas are within 0.75 miles along West Indian Hills Road, in Cleveland County, Oklahoma.
4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED.: The Canadian River is the nearest traditional navigable water (TNW).
5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS: The ephemeral tributary (ET-1) flows through several unnamed tributaries, which flow into the Canadian River.

The stormwater basin (SB-1) is part of an upland constructed ditching/drainage system along the roadside. This feature only conveys water immediately during rain events, this feature is non-relatively permanent water, thus non-jurisdictional.

non-relatively permanent waters; non-tidal wetlands that do not have a continuous surface connection to a jurisdictional water):.

The ephemeral tributary (ET-1) is an unnamed tributary that flows into the Canadian River, this tributary occurs at the headwater within the drainage area. The tributary has a very limited ordinary high water mark, approximately 2 feet wide and less than 1 foot deep. The tributary only flows in response to direct rain events and is a non-relatively permanent water. This feature is non-jurisdictional.

The emergent wetland (0.4 acre) is not mapped on the USGS Topographic Map or NWI Map, however, the agent mapped this feature as an isolated feature which receives water from upland drainage via a swale in the agricultural field the wetland occurs within. The wetland lacks a physical connection to relatively permanent water, thus it is non-jurisdictional.
