MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ SWT-2025-00207.

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States,'" as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in this state due to litigation.

- 3. REVIEW AREA. The review area is comprised of approximately 22.03 acres with center coordinates of latitude: 34.722053°, longitude: -98.487673°, in Section 20, Township 3 North, Range 12 West, in Comanche County, Oklahoma.
- NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The Red River is the nearest downstream TNW (navigable under Section 10 of the Rivers and Harbors Act of 1899)
- FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS: Ephemeral Streams S1 and S2 flow into Medicine Creek that flows into East Cache Creek, that flows into Cache Creek, which flows into the Red River, a navigable water.

- Stream S1 is an ephemeral stream channel that exhibits a discontinuous ordinary high water mark and does not convey relatively permanent flow to a downstream TNW. S1 likely originates from a seep from an upland stock tank located outside of the study area.
- Stream S2 is an ephemeral stream that exhibits a discontinuous ordinary high water mark (OHWM) and does not convey relatively permanent flow to a downstream TNW. Portions of S2 pool and may flow periodically for a short duration following precipitation events. Offsite, S2 widens and loses all characteristics of an OHWM and flows across the landscape in a channelized ditch along the toe of a man-made berm.
- Wetland W1 is an emergent wetland that lacks a continuous surface connection to a jurisdictional water.
