PURPOSE

The purpose of this public notice is to inform you of a proposal for work in which you might be interested and to solicit your comments and information to better enable us to make a reasonable decision on factors affecting the public interest.

SECTION 10

The U.S. Army Corps of Engineers is directed by Congress through Section 10 of the Rivers and Harbors Act of 1899 (33 USC 403) to regulate all work or structures in or affecting the course, condition, or capacity of navigable waters of the United States. The intent of this law is to protect the navigable capacity of waters important to interstate commerce.

SECTION 404

The U.S. Army Corps of Engineers is directed by Congress through Section 404 of the Clean Water Act (33 USC 1344) to regulate the discharges of dredged and fill material into all waters of the United States. These waters include lakes, rivers, streams, mudflats, sandflats, sloughs, wet meadows, natural ponds, and wetlands adjacent to other waters. The intent of the law is to protect these waters from the indiscriminate discharge of material capable of causing pollution and to restore and maintain their chemical, physical, and biological integrity.

Interested parties are hereby notified that the District Engineer (DE) has received an application for a Department of the Army (DA) permit and water quality certification pursuant to Sections 404 and 401 of the Clean Water Act (CWA). The ODEQ hereby incorporates this public notice and procedure as its own public notice and procedure by reference thereto.

<u>Location:</u> The proposed project is in Section 16, Township 24 North, Range 16 East, or at Latitude 36.5649 and Longitude -95.6081, on the west shoreline of Oologah Lake, Rogers County, Oklahoma. The project site can be found on the Winganon, OK 7.5 Minute USGS Quadrangle map.

<u>Project Description:</u> The application is for the discharge of fill material into Oologah Lake. The activity involves modification and repair (addition of new rip rap) to approximately 2,200 linear feet of shoreline and the disposal of weathered riprap on the south side of the existing bank stabilization.

<u>Purpose:</u> The overall purpose is to modify and repair the damaged shoreline to provide protection from erosion caused by flood events. This is not a water dependent activity.

The basic purpose and need of the proposed action is to conduct repairs to the riprap damaged by the 2019 flood event at Oologah Lake.

<u>Description of Work</u>: The Corps proposes to add rip rap toe protection below the normal conservation pool elevation to the existing rip rap placed along the shoreline. Replacement of existing rip rap will occur as needed to replace the weathered stone. The weathered material will be removed and utilized as new bank stabilization along the southern edge of the existing rip rap for approximately 300 linear feet.

Avoidance and Minimization Information: The applicant provided the following statement with regard to how avoidance and minimization of impacts to aquatic resources was incorporated into the project plan: This activity is necessary to maintain the operational functionality of the Oologah Lake Project. The project has been designed to repair and replace damaged rip rap sections along the bank and prevent/stop future erosion of the shoreline. The activity will result in the minimum amount of fill material placed below the ordinary high water mark as deemed necessary by Corps engineering staff to fulfill the purpose of bank stabilization, embankment maintenance, and repair.

<u>Mitigation</u>: The applicant proposes the following as compensatory mitigation for the unavoidable impacts to aquatic resources expected from the proposed project:

A mitigation plan has not been submitted.

The Corps has made no determination at this time with regard to the adequacy of the proposed mitigation relative to the federal mitigation rules and guidance, including Tulsa District's Mitigation and Monitoring Guidelines. Compensatory Mitigation for unavoidable impacts may be required to ensure that this activity requiring a Section 404 permit, if issued, complies with the Section 404 (b)(1) Guidelines. The Corps bears the final decision on the need for and extent of mitigation required if the project proposed herein is authorized.

<u>Project Setting</u>: Oologah Lake is located within the Osage Cuestas ecoregion 40b, defined as: Irregular to undulating plains that are broken by low hills and cuestas with east-facing scarps. Perennial streams occur. Streams are dominated by pools having substrates that are composed of sand, mud, and sometimes, gravel and cobbles. Riffle

areas are moderately common and tend to occur every 250 to 1,300 feet; their substrates are composed of gravel, cobbles, and boulders. In the southern third of Ecoregion 40b, streams are often more slowly moving and more turbid than more northerly portions.

Existing Condition: The shoreline is currently lined with rip rap that has been weathered from flood events and continuous wave action. The flood of 2019 has undercut existing riprap that is in need of repair. The "disposal area" defined in the enclosures is eroding and will be lined with the weathered stone that is removed from the embankment.

<u>Cultural Resources:</u> The DE is responsible to ensure compliance with the National Historic Preservation Act of 1966 (NHPA) (Public Law 89-665), as amended, and other cultural resources laws and Executive Orders. A preliminary review has been completed of the state's records for the presence of sites included in, or eligible for, inclusion in the National Register of Historic Places, as well as the Oklahoma Landmark Inventory Database. Based on the preliminary information, there may be historic properties, as defined by the NHPA, in or within the vicinity of the proposed permit area. The Corps will comply with the NHPA to resolve any potential effects.

<u>Threatened and Endangered Species</u>: The following federally listed species are known to occur in the vicinity or are listed for the county in which the proposed action is located: northern long-eared bat (*Myotis septentrionalis*), American burying beetle (*Nicrophorus americanus*), least tern (*Sterna antillarum*), piping plover (*Charadrius melodus*), red knot (*Calidris canutus rufa*), whooping crane (*Grus americana*), Neosho mucket (*Lampsilis rafinesqueana*), and rabbitsfoot (*Quadrula cylindrica cylindrica*). A copy of this notice is being furnished to the U.S. Fish and Wildlife Service and appropriate state agencies.

We are currently assessing the potential effects of the proposed action on these species and will comply with the Endangered Species Act with regard to any effect of our decision on this permit application.

Evaluation Factors: The decision whether to issue a permit will be based on an evaluation of the probable impacts, including cumulative impacts of the proposed activity and its intended use on the public interest. That decision will reflect the national concern for both protection and utilization of important resources. The benefit which reasonably may be expected to accrue from the proposal must be balanced against its reasonably foreseeable detriments. All factors which may be relevant to the proposal will be considered, including the cumulative effects thereof: conservation, economics, aesthetics, general environmental concerns, wetlands, historic properties, fish and wildlife values, flood hazards, floodplain values, land use, navigation, shoreline erosion and accretion, recreation, water supply and conservation, water quality, energy needs, safety, food and fiber production, mineral needs, considerations of property ownerships, and, in general, the needs and welfare of the people. A permit will be denied if the discharge does not comply with the Environmental Protection Agency's 404(b)(1) Guidelines. Subject to the 404(b)(1) Guidelines and any other applicable guidelines or

criteria, a permit will be granted unless the DE determines that it would be contrary to the public interest.



Comments: The Corps of Engineers is soliciting comments from the public; Federal, state, and local agencies and officials; Indian Tribes; and other interested parties in order to consider and evaluate the impacts of this proposed activity. Any comments received will be considered by the Corps of Engineers to determine whether to issue, modify, condition or deny a permit for this proposal. To make this decision, comments are used to assess impacts on endangered species, historic properties, water quality, general environmental effects, and the other public interest factors listed above. Comments are used in the preparation of an Environmental Assessment and/or an Environmental Impact Statement pursuant to the National Environmental Policy Act. Comments are also used to determine the need for a public hearing and to determine the overall public interest of the proposed activity. Any person may request in writing, within the comment period specified in this notice, that a public hearing be held to consider this application. Requests for public hearings shall state, with particularity, the reasons for holding a public hearing. Comments concerning the issuance of this permit should be received by the DE no later than the expiration date of this public notice. Comments concerning water quality impacts will be forwarded to ODEQ for consideration in issuing a Section 401 Water Quality Certification for the proposed project. Work may **not** commence until decisions have been made on both Sections 401 and 404.


