The review area also contains two adjacent emergent wetlands (W1- 0.042 acre and W2- 0.051 acre). Additionally, there is one isolated wetland (W3- 0.342 acre) that lacks adjacency or a link to navigable waters or interstate commerce.**

#### B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). Summarize overall biological, chemical and physical functions being performed: W1 and W2 are adjacent to a non-RPW that contributes flow downstream to the Canadian River, a Section 10 TNW. These wetlands provide suitable habitat to plant and wildlife species to include various reptiles, amphibians, crayfish, and other macro invertebrates. The wetlands also function to purify water flowing downstream by filtering out pollutants from the watershed and provide additional flood control storage for the watershed.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

This feature is not depicted as a blue line feature on the USGS Topographic map. This feature has been determined exhibit ephemeral flow based on the limited frequency and volume of flow anticipated from the 72 acre drainage area. This stream does not have any ground water influence due to the landscape setting (headwater). The review area is comprised of an electric substation, mowed pasture, and a riparian corridor along the stream. The stream has two adjacent forested wetlands (W1, 0.042 acre and W2, 0.051 acre) within the review area. The wetlands provide limited habitat for aquatic organisms during the wettest time of year. The stream and its adjacent wetlands provide some filtering of associated pollutants within the drainage area. The stream performs few ecological functions based on a lack of in-stream habitat complexity. The stream and its adjacent wetlands provide limited benefits to the nearest RPW (unnamed tributary to the Canadian River) however, these functions/benefits don't equate to a more than speculative or insubstantial benefit to the Canadian River (TNW), which is approximately 4 river miles from this water. This non-RPW and its associated adjacent wetlands do not meet the Significant Nexus standard set within the Rapanos Guidance document and is supported within the agent's delineation report as well as this form..
