Explain: **Within the review area, the delineated features R6-2 (323 lf) and R6-1a (823 lf) were determined to be ephemeral drainage features that lacked a bed and bank, OHWM, and hydrology consistent with that of a stream.**

Therefore, R6-2 and R6-1a were not considered waters of the U.S. Within the review area, the delineated feature R6-1 (296 lf) was determined to be a non-jurisdictional ephemeral stream channel that lacks sufficient functions and

connectivity to a downstream Traditionally Navigable Water (TNW) to meet the significant nexus standard. Within the review area, the delineated feature PUB-1 (0.31 acre) was determined to be a non-jurisdictional impoundment of R6-1 that was constructed prior to 1964 for the purpose of watering livestock.

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Describe flow regime: During the site visit and during the provided lentic and lotic waterbodies delineation performed by the applicant hired consultant, R4SB-1 and R4SB-2 were observed to exhibit flowing water, a defined bed and bank, and an OHWM consistent with that of an intermittent/seasonal flow regime.

Other information on duration and volume: R4SB-1 and R4SB-2 exhibit seasonal flow that is influenced by rain events and the water table.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- 1. Significant nexus findings for non-RPW that has no adjacent wetlands and flows directly or indirectly into TNWs.** Explain findings of presence or absence of significant nexus below, based on the tributary itself, then go to Section III.D: The review area contains a non-RPW tributary (R6-1, 296 lf), which is best characterized as an ephemeral headwater that experiences flow during and immediately after rain events. This feature has been determined exhibit ephemeral flow based on field observations and the limited frequency and volume of flow anticipated from the 84 acre drainage area. This stream does not have a ground water influence due to the landscape setting (headwater). Additionally, R6-1 was observed to have been impounded (PUB-1) without an outflow pipe at some point prior to 1964 for the purpose of watering livestock. Because of this, the former downstream portion of R6-1 has lost all indicators of hydrology and has become completely vegetated throughout. R6-1 has now created an erosional feature within the uplands that traverses from the Northwest corner of PUB-1 westward before converting to overland sheet flow. Therefore, due to R6-1's lack of connectivity and less than speculative or insubstantial benefit to the Arkansas River (TNW), which is located approximately 180 river miles from this water, R6-1 does not meet the significant nexus standard set within the Rapanos Guidance document.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The review area is approximately 80 acres and contains two jurisdictional relatively permanent streams (R4SB-1 and R4SB-2). The review area also contains two non-jurisdictional ephemeral drainage features that lack the hydrologic characteristics of a stream channel (R6-2 and R6-1a) and a non-jurisdictional livestock pond (PUB-1) that is not an impoundment of WOTUS and does not have a downstream connection to WOTUS. Additionally, a non-jurisdictional ephemeral stream channel (R6-1) was delineated within the review area that was determined to lack a clear connection or significant nexus to the downstream TNW.
